# JATF HOSTEL (BANGALORE CENTRAL) TRUST

## Rules and Regulations for Students of JATF Hostel (Bangalore Central) Trust

1. It shall be sole duty and responsibility of every Student that she shall:
  - a. occupy the only room which is allotted to her
  - b. keep the room neat and clean and do not throw any garbage or spit in the Hostel premises
  - c. shall not put any lock to the main door of the room, but keep her luggage and personal belongings and valuables, if any, in the room only under lock and key, where necessary, as the Student herself will be personally responsible for her belongings
  - d. take utmost care while using the furniture, fixtures, electrical & other fittings or any other assets of the Hostel
  - e. be responsible and liable to compensate for any damage/s to any property of the Hostel due to the Student negligence or willful act
  - f. refrain from watching any banned or pornographic films / material
  - g. conserve use of electricity and water by avoiding wastage
  - h. not to use in the room any electrical appliances / gadgets except laptop and mobile
  - i. keep lights, fans or any other electrical gadgets off, while you are not in the room, those who are found to keep light & fan on, will be charged Rs.100 as penalty
  - j. not to bring any outside furniture in the room
  - k. not to cook any food in the room
  - l. not to bring or eat any non-vegetarian food and no smoking, drinking liquor, chewing of tobacco, eating pan masala or gutkha in the Hostel premises
  - m. not to take any visitor in the room without prior permission of the Hostel Convener / Manager
  - n. not to use any staff of the Hostel for personal work or to bring inside the room an outside servant for her personal work
  - o. not to stick any posters, pictures or write any slogans or remarks on the walls of the premises or hanging banners or distribute leaflets within the Hostel premises.
2. Student shall return to the Hostel premises before 08.30 pm. The entrance of the hostel premises shall remain closed between 09.00pm to 6.00 am daily and no Student will be allowed to enter the premises during this period, except with the prior permission of the Hostel Convener / Manager.
  - a. Bio-metrics Registration is compulsory at time of admission.
3. Student staying out overnight or going out on any leave shall intimate in the prescribed format and also note to enter her particulars in the Outstation Register, while going out and sign the same on return.
4. Student shall keep informed the Hostel Convener / Manager of any mishap, emergency or health problem (including contagious disease) or any serious matter.
5. Student shall not enter into any room other than one allotted to her without the permission of the occupant.
6. Student shall maintain peaceful and pleasant environment during her stay in the hostel and shall refrain from creating any kind of nuisance or disturbance in the Hostel premises.
7. Student shall not engage in any illegal or criminal act including of cyber crime inside or outside the premises. In any case, the Hostel authorities will not be liable or responsible under any circumstances for any illegal act of the Student.
8. Student shall not organize in the Hostel premises any party / religious function or gathering without prior permission of the Hostel Convener / Manager.
9. The Father / Guardian of the Student shall ensure timely payment of fees and /or Hostel dues, if any, failing which the Management will have the right to recover the over dues with or without the interest for the late period or even to suspend / expel the Student from the Hostel.
10. Student must attend all program / seminar / event organised by the Hostel Management.

## POWERS OF THE MANAGEMENT

Student understands that the Management shall enjoy the powers as enshrined in the bye laws of the Hostel and more particularly the following matters and the Student and her Father / Guardian and the Local Guardian shall be bound by the decision of the Management in the event of any violation by the Student .

1. If it is found that, any of the information furnished by the Student / her Father / Guardian is not correct or at variance with the actual position, the Management may reject the application for admission or cancel or suspend the admission at a later date and no grievance of any kind shall be entertained in this regard.
2. If the Student is found guilty of violation of any rules & regulations or engages herself in any illegal activity or indecent behavior with other Students or Administrative staff of the Hostel, the Management may revoke her admission.
3. The Hostel Convener / Manager can inspect any room at any time without any prior permission of the Student .
4. The Management at its own discretion may ask any Student, who is found to be infected with any contagious disease to leave the premises and to allow her to re-enter only if the Student is able to produce Medical Certificate of fitness from a Practicing Doctor.
5. The Management shall normally not entertain any application/s for change of room except in exceptional circumstances.
